6. The authorised representative or the officer of the public authority and the appellants/complainant/third party is advised to carry a "proof of identity".

7. Take notice that in default of your appearance on the time and date mentioned aforesaid, the case shall be heard and decided in your absence. There is no scope for adjournment and review.
