5. CPIO is also directed to inform the third party, if any, so as to enable it to defend or present its

case before the Commission. Third Party may choose to be present before the Commission either in person or through its duly authorized representative for hearing, or they may also file a written submission to the Commission before the hearing.

6. The authorised representative or the officer of the public authority and the appellant/complainant/third party is advised to carry a "proof of identity".

7. Take notice that in default of your appearance on the time and date mentioned aforesaid, the case shall be heard and decided in your absence. There is no scope for adjournment and review.
