- 4. All the parties may submit their written submission with reference to the application made under section 18 read with section 20 of RTI Act, 2005. if any, to the Commission at least 7 days before

the date of hearing. A copy of the same **shall** be served upon opposite party. - 5. CPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission.
