- (b) If the CPIO attending the hearing before the Commission does not happen to be the concerned CPIO, it shall still be his/her responsibility to ensure that the CPIO(s) concerned must attend with

complete file concerning the RTI request, the hearing along with him.

- 4. All the parties may submit their written submission, if any, to the Commission at least 7 days before the date of hearing. A copy of the same shall be served upon opposite party. - 5. CPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission.
