present the case before the Commission. The third party may choose to be present before the Commission on phone or through his/her duly authorized representative for hearing on phone, or they may also file written submission to the Commission before the hearing.

- 5. The authorised representative or the officer of the public authority and the appellant/complainant/third party is advised to carry a "proof of identity" **along with the authorization letter**.
- 6. Second Appeals/Complaints, where submissions have been received, at least three days before the date of hearing, will be decided on merits, as per the submissions received and documents on record, in case the Appellant/Complainant is unable to attend the hearing.
- 7. Take notice that in default of your attendance/participation in the audio hearing on the time and date mentioned above, the case shall be heard and decided on the basis of available records. It is made clear that no adjournment and review shall be granted
