All the parties may submit their written submission with reference to the application made under section 19 read with section 20 of RTI Act, 2005. if any, to the Commission at least 7 days before the date of hearing. A copy of the same shall be served upon opposite party. - 5. CPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission. Third Party may choose to be present before the Commission either in person or through its duly authorized representative for hearing, or they may also file a written submission to the Commission before the hearing.
