- 6. Second Appeals/Complaints, where submissions have been received, at least three days before the date of hearing, will be decided on merits, as per the submissions received and documents on record, in case the Appellant/Complainant is unable to attend the hearing.
- 7. Take notice that in default of your attendance/participation on the time and date mentioned above, the case shall be heard and decided on the basis of available records. It is made clear that no adjournment and review shall be granted
