- 4. All the parties are required to observe proper decorum and etiquette throughout the hearing.

Instructions to Appellant/ Complainant

- 1. The appellant/complainant may present his/her case(s) in person or through his/her duly authorized representative.
- 2. The authorized representative or the appellant/complainant/third party is advised to carry a **"proof of identity" along with the authorization letter**.

Instructions to CPIO

- 1. CPIO/PIO should personally attend the hearing; if for a compelling reason(s) he/she is unable to be present, he/she has to give reasons for the same and shall authorise an officer not below the rank of CPIO.PIO, fully acquainted with the facts of the case **and bring complete file/file(s) with him.**
- 2. If the CPIO attending the hearing before the Commission does not happen to be the concerned CPIO, it shall still be his/her responsibility to ensure that the CPIO(s) concerned must attend with complete file concerning the RTI request, the hearing along with him.
- 3. The CPIO is required to mention his Name and last six digit of the CIC file number mentioned above in the notice, in the display name at the time of joining.
- 4. CPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission. Third Party may choose to be present before the Commission either in person or through its duly authorized representative for hearing, or they may also file a written submission to the Commission before the hearing.
