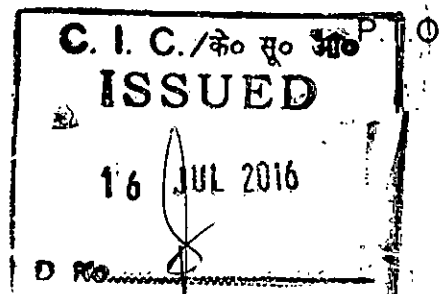
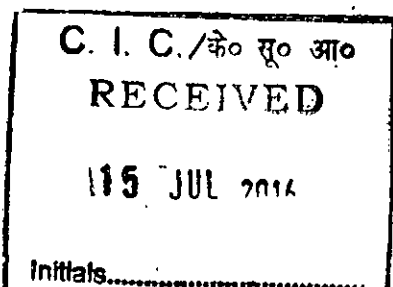
Decision with reasons:-

1. In the RTI application, the appellant has sought information regarding his previous letter dated 24.07.2015 which has been mentioned as RTI application. The CPIO Shri Dinesh Kumar has informed vide letter dated 01.10.2015 that:-

"From your RTI application dated 24.07.2015 and the enclosures which you have sent along with the above RTI application, it has been noted that the matter pertains to other Public Authority and not CIC, hence no action could be taken."

2. The appellant was contacted over phone who intimated that he wanted to know the action taken by the CIC on his 2nd appeal filed in the Commission against the Kolkata High Court and he has also referred to in the RTI application regarding the Kolkata High Court judgment in WP No.27978/2015. He has also informed that his 2nd appeal No.CIC/RM/C/2014/00537 has already been disposed off vide order dated 25.05.2016 and 04.04.2016.

3. The CPIO, Shri Dinesh Kumar without understanding the facts replied the RTI application for which the appellant has to file this first appeal unnecessarily.
