The appellant was given an opportunity to present his case, either personally or through an authorized representative or through audio conferencing. The appellant was present when Shri Jitender Khanna, SO, RTI Cell and Shri O.P. Gupta, SO, Legal Cell were also present.

**Decision with reasons:-**

2. During the hearing, the appellant did not press the Points 1, 2, 4 & 5 of the RTI application. The appellant has stated during the hearing that he only wants to know whether the penalty of Rs.25000/- imposed by Shri Shailesh Gandhi, former Information Commissioner on Mr. S. D. Tomar, EE(M-I) & Deemed PIO, MCD vide decision No.CIC/SG/A/2011/002658/16315 dated 12.01.2012 has been recovered or not as sought in Point 3 of the RTI application. Shri O.P. Gupta, SO, Legal Cell has intimated during the hearing that the penalty amount of Rs.25,000/- has already been recovered vide Cheque No.033808 dated 21.11.2013 drawn on SBI. The appellant was satisfied with the reply of the SO, Legal Cell.

3. The appeal is, therefore, disposed of accordingly.

4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 185, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
