**Decision with reasons:-**

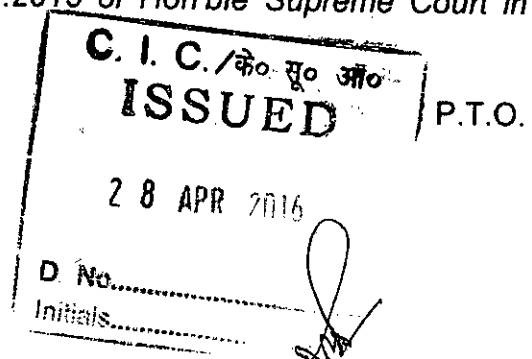
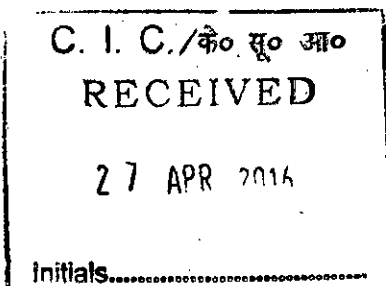
2. In the RTI application the appellant has sought following information:-

*"This has reference to CIC orders vide CIC/SA/A/2015/000627 dated 24.11.15 and to request that following information may kindly be supplied:*

- Certified copy of the sufficient information having been supplied by PIO to Applicant and its copy supplied to O/O CIC as stated in above decision may kindly be supplied.*
- Certified copy of explanation submitted by PIO as to why maximum penalty should not be imposed for not complying with the FAA order within the prescribed period which is available with office of CIC may also kindly be supplied."*

The then CPIO cum DR to IC(SA), Shri Umesh Chandra Joshi has furnished the reply, as under:-

*"With reference .....it is stated that no record for the information sought is available in the light of the decision dated 04.01.2015 of Hon'ble Supreme Court in SLP(C) No.34868 of 2009."*


