**Decision with reasons:-**

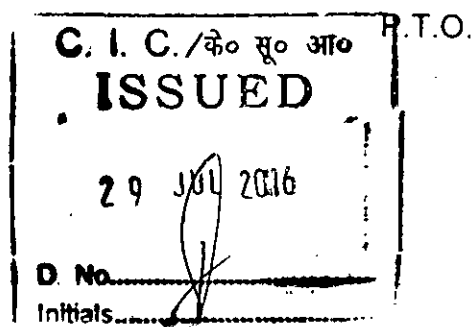
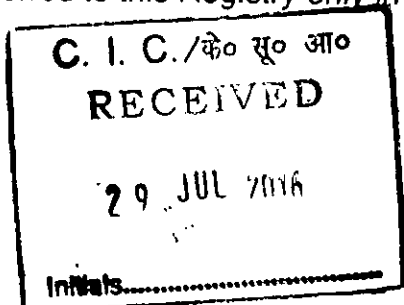
1. On Point 1(a) to (c) of the RTI application has sought the registration number and present status of his following complaints filed in the CIC:-

"1(a) Complaint dated 23.04.2013 attached with an Affidavit addressed to Information Commissioner, Shri M.L. Sharma, CIC vide Diary No.136491 dated 23.05.2013 (Ref: CIC Order No.CIC/A/RM/Q/2012/000011/LS dated 13/05/2013).

(b) Complaint dated 18.10.2013 attached with an Affidavit addressed to Information Commissioner, Shri Rajiv Mathur, CIC vide Diary No.175743 dated 18.10.2013 (Ref: CIC Order No.CIC/A/RM/A/2013/000070 dated 31.08.2013)

(c) Complaint dated 10/08/2013 against non-compliance of CIC Decision No.CIC/DS/C/2011/00678/VS/00939 dated 25.09.2012 addressed to Information Commissioner, Shri Vijay Sharma, CIC submitted through CAPIO, Delhi GPO-110006 forward to CIC vide letter No.CPM/RTI/CR/Appeal/42/13-14 dated 13.08.2013 delivered by registered post.

2. DO to IC(SA) vide letter dated 13.12.2015 has informed the appellant that "no record for the information sought is available in this office, as the subject matter was transferred to this Registry only in July 2015."



3. Since these two cases are very old and pertaining to the public authority 'University of Delhi' under Ministry of HRD, the CPIO cum DO to IC(SA) is directed to take the assistance of Shri A.K. Gehlot, JS(MR) who is compiling the files of this Commission and get the files and provide the information to the appellant as sought in the RTI application within 3 weeks from the date of receipt of the order.

4. On Point 1(c), the appellant has mentioned the year of the case file as CIC/DS/C/2011/00687/VS/00939 but this file is not concerned with the appellant and it seems that the appellant has mentioned this file number instead of No. CIC/DS/C/2012/00687/VS/00939 which is concerned with the appellant. In this file, the public authority is DDA under Ministry of Urban Development. **Direction in this regard is given to the CPIO cum DO to IC(KY) to provide the information on this point to the appellant within 10 workings days from the date of receipt of the order. If the concerned case file is not available in the registry of IC(KY), DO to IC(KY) may take the assistance of Shri A.K. Gehlot, JS(MR) who is compiling the old files of this Commission and get the file and provide the information to the appellant.**

5. Information on point 2 of the RTI application has already been provided to the appellant by Shri Dinesh Kumar, DR & CPIO (CR) vide letter dated 15.01.2016.

6. Information on point 3 of the RTI application has not been provided by any of the CPIO(s). It is observed that the CPIO, RTI Cell has transferred the RTI application to Shri Dinesh Kumar, DR in CR Section and Shri Umesh Chandra Joshi, ex. DO to IC(SA) without indicating the point numbers in the RTI application concerning to them. **The Nodal Officer and CPIO, RTI Cell is advised to mention the specific point number while transferring/forwarding the RTI application to other CPIO(s) so that the concerned CPIO can provide the specific information to the RTI applicant.**

**The CPIO, RTI Cell is directed to provide information on Point 3 to the appellant by taking assistance under Section 5(4), if required, from holder of the information within 2 weeks from the date of receipt of the order.**

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.


