Decisions with reasons:

The appellant has filed this first appeal on not getting information/response from the CPIO on his RTI application dated 20.10.2015. From the documents available on the RTI portal in respect of this RTI application, it is observed that Shri Y.K. Singhal as CPIO RTI Cell has intimated the appellant vide his letter dated 18.12.2015 that his RTI application has been forwarded to Shri Y.K. Singhal, JS (Law) for sending reply to the appellant directly. Again Shri Y.K. Singhal as J.S (Law) vide letter dated 29.01.2016 has intimated the appellant that his RTI application has been transferred to Shri Singhal, CPIO RTI Cell for sending reply directly to the appellant but no reply has been provided by Shri Y.K. Singhal either in the capacity of J.S (Law) or CPIO, RTI Cell.

Shri Y.K. Singhal, Nodal Officer, RTI Cell and J.S (Law) is directed to provide information to the RTI applicant within 10 days from the receipt of this order, if required, take assistance U/s. 5 (4) from the holder of information.

2. The appeal is disposed of accordingly.

3. In case the he appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Room No. 185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
