

**Decisions with reasons:**

- 1.(i) The appellant has sought information regarding the complaints received in the Commission against Information Commissioners and Chief Information Commissioner. The CPIO has provided point-wise information after taking assistance from the PA to Secretary, CIC.
- (ii) On Point No. 1 & 2 the appellant has asked for a total number of complaints, letters and reminder received from citizen/NGOs etc. relating to the complaint against CIC and ICs. The number has already been provided by the CPIO/ holder of information.
- (iii) On point No. 3, action taken on complaints received from citizens/NGOs etc. against CIC/IC. The information provided by the CPIO/holder of information is factual and no intervention is required.
- (iv) On point No. 4, the appellant has asked for the time required as per Citizen charter/or any other Act/Rule to reply the letters/complaints.
- (v) On point No. 5, the appellant has asked for the name and designation of the officer, who is supposed to reply the letters about the complaints filed against Information Commissioners/Chief Information Commissioner.
- (vi) On point No. 6, no specific information has been asked for.
- (vii) On point No.7, the appellant wants some web link of the website [www.rti.gov.in](http://www.rti.gov.in) .
- (viii) **It seems that no information has been provided to the appellant on point no.4 to 7. The CPIO, RTI Cell is directed to provide information on point No. 4 to 7 after taking assistance from the concerned.**

2. The appeal is disposed of accordingly.

3. In case the he appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Room No. 185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
