Decision with reasons:-

- 2. In view of the above, direction is given to Shri V.D. Naniwadekar, CPIO cum DO to IC(YA) to intimate the present status of the above said 2nd appeal to the appellant within 2 weeks from the date of receipt of the order and since the appellant is a senior citizen, his 2nd appeal may be given priority as per the provision of the RTI Act.
- 3. The appeal is, therefore, disposed of accordingly.
- 4. There has been some delay on disposal of the appeal as the FAA in the Commission is not a full time appellate authority as per the RTI Act 2005. Being Additional Secretary in the Commission's office she also has other administrative works to perform.
