**Brief facts of the case :-**

Shri Sanjiv Chaturvedi has filed first appeal dated 22.01.2015 against the reply of Shri Prakash, CPIO cum DO to CIC dated 06.01.2016 in response to the RTI application dated 14.12.2015. Appellant was present. Shri Subhash Chandra Sharma, CPIO cum DO to CIC who joined the Commission on same day in place of Shri Prakash, Shri O.P. Gupta, SO(Legal) and Shri Jitendra Khanna, SO, RTI Cell on behalf of Shri Y.K. Singhal, JS(Law) cum CPIO, RTI Cell were also present.

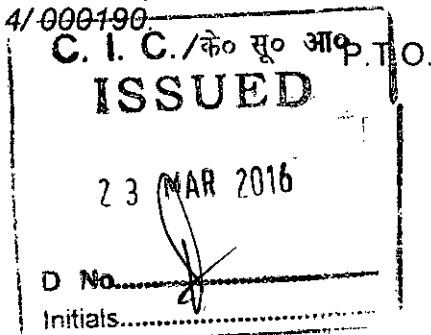
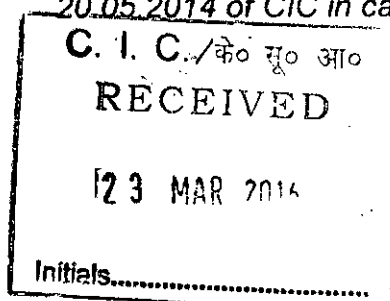
**Decision with reasons:-**

2. The appellant has sought following information in his RTI application dated 14.12.2015:

"I. Kindly provide all the file noting/documents/correspondences regarding order passed by Shri Vijai Sharma, the then Chief Information Commissioner on 30.11.2015 in appeal No.CIC/SS/A/2014/000190.

II. Kindly provide me certified copies of all the correspondences/file noting/ documents related to action taken on my representation dated 15.06.2015, titled '**Regarding implementation of order No.CIC/SS/A/2014/000190 dated 20.05.2014 in case titles as Sanjiv Chaturvedi Versus Prime Minister's Office passed by Hon'ble Central Information Commission and for action against concerned officials under section 20(1) and compensation to the applicant under section 19(8) (b) of RTI Act, 2005, due to detriment caused by extraordinary delay in supply of information**', addressed to Shri Vijai Sharma, the then Chief Information Commissioner.

III. Kindly provide me certified copies of all the correspondences/file noting/ documents related to the decision taken by the Central Information Commission on review application filed by the CPIO of the Prime Minister Officer in July, 2014, and on 25<sup>th</sup> August, 2014, regarding order dated 20.05.2014 of CIC in case No.CIC/SS/A/2014/000190.



IV. Kindly provide me the certified copy of the Show Cause Notice dated 06.06.2014, issued to the CPIO of the Prime Minister Office in case No.CIC/SS/A/2014/ 000190, reply of the concerned CPIO and certified copy of all the file noting/documents/ correspondences on decisions taken by the CIC on the said show cause notice."

In response to Points I to IV of the RTI application, Shri Prakash, ex. CPIO cum DO to CIC responded that all these information are available on public domain i.e. www.cic.gov.in.

3. However, from the perusal of the CIC's website, no such information is available in public domain except order dated 20.05.2014 and adjunct order dated 30.11.2015 in case File No. CIC/SS/A/2014/ 000190. Hence, it is observed that the CPIO did not apply his mind before furnishing the reply. Since Shri Prakash is on leave, direction is given to Shri Subhash Chandra Sharma, CPIO cum DO to CIC who has joined the Commission today in place of Shri Prakash to re-visit the matter and furnish the reply of the RTI application to the appellant within 2 weeks from the date of receipt of this order.

4. The appellant has no other issues, therefore, the appeal is disposed of accordingly.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 326, 2<sup>nd</sup> Floor, 'C' Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
