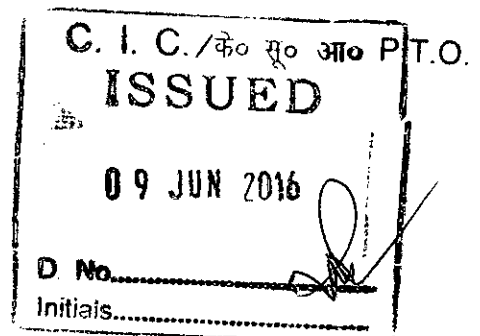
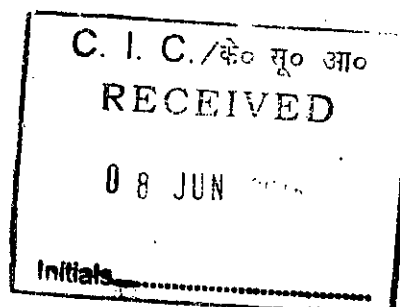

The appellant was present when Shri Y.K. Singhal, JS cum CPIO, RTI Cell, Shri A.K. Gehlot, JS(MR) and Shri Sushil Kumar, DS(Admin) cum CPIO were also present during the hearing.

Decision with reasons:-

1. On Points (A) & (H) of the RTI application, the appellant sought digital data for diarizing the dak received in the CIC for the year 2013 and 2014 in a CD for which a postal order No.79G 155736 for Rs.50/- being copying fees has already been deposited by the appellant. Shri A.K. Gehlot, JS(MR) cum CPIO vide his letter dated 25.08.14 replied that the information is not available. The reply of the JS(MR) is not appropriate, therefore, **direction is given to him to revisit the matter and provide the information to the appellant within 2 weeks from the date of receipt of the order.**

2. On Point (B) of the RTI application, the appellant has sought a copy of relieving report of Shri Ved Prakash from the Legal Cell and also the copy of the charge report along with the list of documents, files, folders, handed over by him at the time of relieving from CIC. **The first part of the point viz relieving report of Shri Ved Prakash will be provided by Shri Sushil Kumar, DS(Admin) and second part viz charge report, list of documents etc will be provided by Shri Y.K. Singhal, JS(Law) within 2 weeks from the date of receipt of the order.**

3. On Points (C) & (H) of the RTI application, direction is given to Shri Sushil Kumar, DS(Admin) cum CPIO to provide the information to the appellant within 3 weeks from the date of receipt of the order.

4. On Points (D) & (G) of the RTI application, direction is given to Shri Y.K. Singhal, JS(Law) cum CPIO to offer inspection to the appellant with mutual consent.

5. On Point (E) of the RTI application, Shri Y.K. Singhal, JS(Law) has stated during the hearing that as on date no dak folder is kept in the Legal Cell/JS(Law).

6. On Point (F) of the RTI application, direction is given to Shri Y.K. Singhal, JS(Law) cum CPIO to provide the information to the extent possible to the appellant within 2 weeks from the date of receipt of the order.

7. The appeal is disposed off.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
