- (E) Please provide the information as to the manner of maintenance of records in relation to the dak received in the Legal Cell or in the Office of JS (Law) and the manner of keeping the records for the dak which has neither been sent to other sections nor placed in the relevant file. In case, a separate folder is kept for such dak, kindly intimate number of pages it contains. The information for this point (E) is required from 01.01.2014 till the date of providing the information.

(F) Please provide the number of dak for the years 2011 to 2014 which are missing from the Legal Cell or Office of the JS(Law). The yearwise C. I. Cinfognation may be provided in this respect.
