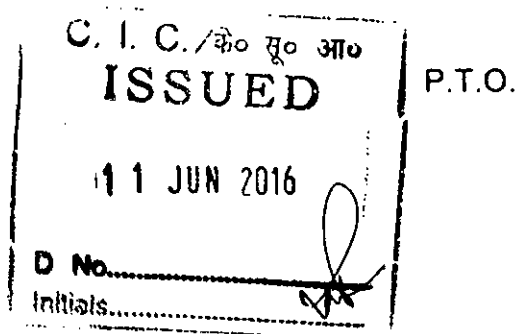
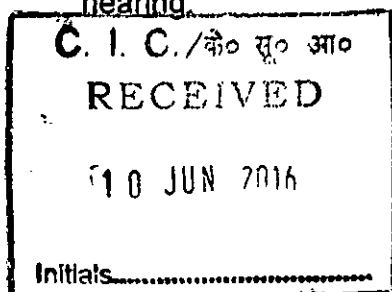
The appellant was present when Shri M.K. Sharma, Registrar, Shri Y.K. Singhal, JS cum CPIO, RTI Cell and Shri V.K. Sharma, DO to IC(SB) were also present during the hearing.

**Decision with reasons:-**

2. On points (A), (B), (C) & (E) of the RTI application, the appellant has sought certain information related to the Case No.CIC/SA/C/2013/000017. The CPIO cum IC(SB), Shri V.K. Sharma has replied vide his letter dated 12.01.2016 that concerned file was heard by IC(KY) on 27.02.2015 and the same has not been received in his registry and has requested DR to IC(KY) to forward the file for taking necessary action.

On perusal of the web site of the Commission, it is seen that the above said case was heard by IC(YA) on 27.01.2015 and not by IC(KY) as stated by DO to IC(SB). Hence the CPIO cum DO to IC(SB) is advised to be careful, in future before furnishing any reply of the RTI application and he is also directed to re-visit the matter and provide the information to the appellant within 3 weeks from the date of receipt of the order.

3. Point (D) of the RTI application has not been pressed by the appellant during the hearing.
