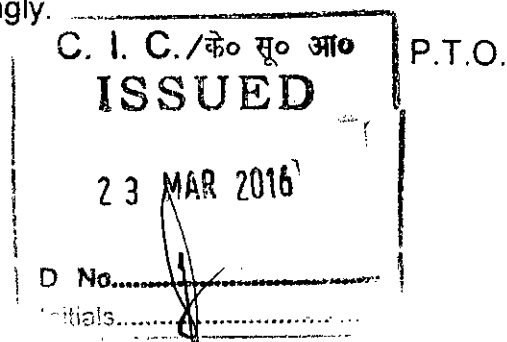
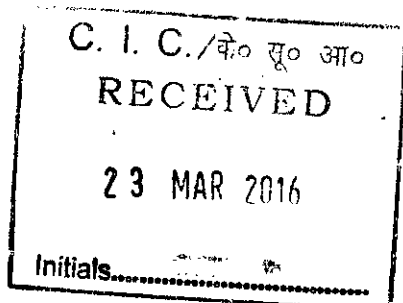

Decision with reasons:-

2. The appellant is aggrieved that he has filed an RTI application dated 07.09.2015 but he has not received the response from the CPIO. From the perusal of the computerized dak management system, it is seen that the said RTI application has been diarized as Dy.No.165552 dated 06.10.2015 and Central Registry is showing as dealing officer and in the remarks columns it is showing T/F to Nodal CPIO. However, the matter has been enquired from the CPIO, RTI Cell who intimated that said RTI application has not been received in the RTI Cell.

Since the appellant has enclosed a copy of the said RTI application along with its enclosure, which is enclosed herewith and **direction is accordingly given to Shri Y.K. Singhal, JS cum CPIO, RTI Cell to register the RTI application within 02 working days from the date of receipt of this order.**

3. The appeal is, therefore, disposed of accordingly.

4. There has been some delay on disposal of the appeal as the first appellate authority was on leave in between and also since FAA in the Commission is not a full time appellate authority as per the RTI Act 2005. Being Additional Secretary in the Commission's office she also has other administrative works to perform, which does not allow sometimes to dispose the appeals within the time limit due to a large number of appeals to be disposed of by the FAA.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
