

**Decision with reasons:-**

1. The appellant is aggrieved with the reply dated 15.02.2016 of the CPIO, RTI Cell. In the RTI application, the appellant has sought following information:-

- "1. Details of provisions/section in RTI Act wherein an applicant can file an appeal under section 19 and section 18 jointly in one appeal, praying information, compensation and penalty on CPIO in addition departmental action against CPIO/First Appellant Authority.
2. Details of provisions/section in RTI Act wherein an applicant cannot file an appeal under section 19 and section 18 jointly in an appeal, praying information, compensation and penalty on CPIO in addition departmental action against CPIO/First Appellate Authority.
3. Details of provisions/section under which Information Commissioner can dismiss/dispose the appeal filed with prayer under section 18 and section 19, praying information, compensation and penalty on CPIO in addition departmental action against CPIO/First Appellate Authority."

2. The CPIO, RTI Cell has rightly intimated that the applicant may refer to the RTI Act, 2005 and RTI Rules, 2012, which are already available in the public domain because the CPIO cannot interpretate or explain the provisions made in the RTI Act, 2005 and RTI Rules, 2012.

The appeal is, therefore, disposed of accordingly.
