The appellant vide his letter No.RTI/P-737/9679/16/R20142 dated 13.09.2016 has intimated that he would be busy in Pooja and other religious ceremonies on the occasion of Anant Chaturdashi (Jain's Annual Day), his presence for the hearing may be dispensed with and the appeals may be decided on the material available on records. He also stated that in case, CPIO has filed any written submissions/replies, provide a copy thereof so that he may file a response and in that circumstances, appeals may be decided after consideration of his response. In this regard, it is stated that no written submission has been received from any of the CPIO(s). Shri M.K. Sharma, Registrar, Shri Ashok Kr Sharma, CPIO, RTI Cell, Shri V.K. Sharma, DO to IC(SB), Shri Krishan Avatar Talwar, DO to IC(KY), and Shri R.P. Grover, DO to IC(YA) were present during the hearing.

## Decision with reasons:-

- 2. On Point (A) of the RTI application, the appellant has sought inspection of all records of case File No.CIC/CC/A/2015/001725-BS. The CPIO & DO to IC(BS) vide letter dated 22.01.2016 has already offered inspection to the appellant on any working day between 1600 to 1630 hrs., hence no further action is required.
- 3. On Point (B) of the RTI application, the appellant sought inspection of case File No.CIC/YA/C/2014/000173 and No.CIC/YA/C/2014/000174. The CPIO & DO to IC(YA) vide his letter dated 24.01.2016 has also offered the inspection, hence no further action is required.
- 4. On Point (C) of the RTI application, the CPIO & DO to IC(SB) vide letter dated 10.02.2016 has informed the appellant that:-

"File No.CIC/SS/A/2012/003262 has not been received in this registry so far. Hence, this registry is unable to provide the sought information. However, in-charge, Record Room-CIC, is being requested to forward the file, if available with them, to this registry for taking necessary action in the matter."

The CPIO and DO to IC(SB), Shri V.K. Sharma is directed to take the assistance of JS(MR) to see whether the file is available in the scanned documents and get the copy and provide the requisite information to the appellant within two weeks from the date of receipt of the order.

- 5. On Point (D) of the RTI application, the CPIO & DO to IC(SB) vide letter dated 10.02.2016 has demanded further fee as photocopying charges for obtaining authenticated copies of 4 pages available in case File No.CIC/VS/A/2014/002510/SB and also offered inspection of the above said case file. Hence, no further action is required.
- 6. On Point (E) of the RTI application, the appellant has sought following information:-

"Please provide the name and designation of the official in whose physical custody the files relating to the cases listed in the enclosed list marked as Annexure-A, has been as on 19-1-2016. Please also provide the proposed date of hearing in these cases. Please also intimate the name of the Information Commissioner who has to hear these cases."

The CPIO, RTI Cell is directed to inform the appellant regarding the present position in respect of files listed in Annexure-A after taking the assistance from the concerned to the appellant within 3 weeks from the date of receipt of the order.

- The appeal is disposed off.
- 8. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
