**Decision with reasons:-**

2. During the hearing, the appellant has stated that he is aggrieved with the response dated 08.02.2016 of Shri Y.K. Singhal, JS(Law) on Points (A), (C) & (D) that to collate and collection of the information would disproportionately divert the resource of his office. The CPIO has also referred the order of FAA in case file No.CIC/AA/A/2015/338, 378, 406 & 407 and stated that inspection in these RTI applications will be provided in due course. The appellant further stated during the hearing that he will accept whatever possible information is provided to him by the CPIO without any objections. **Direction is accordingly given to the CPIO, Legal Cell to provide the information as available and to the extent possible to the appellant within 3 weeks from the date of receipt of this order.**

3. The appeal is, therefore, disposed off accordingly.

4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
