The appellant was present during the hearing when Shri A.K. Gehlot, JS(MR) and CPIO, RTI Cell, Shri V.K. Chandok were also present.

Decision with reasons:-

- 2. In the RTI application, the appellant has sought following information:-
 - "(A) Please provide copies of the RTI response given to the various RTI Applicants by CIC from 1-1-2015 till the date of providing the information (excluding the response given to present Aplicant Shri R.K. Jain). This proactive disclosure of this information has been directed by the DoPT in its OM No.1/6/2011-IR dated 15.04.2013."
- 3. The similar information was sought by the appellant in the other RTI application earlier on which direction was already issued in F.No.CIC/AA/A/2016/101, CICOM/A/2016/00100, CICOM/R/2016/00146 dated 18.03.2016 and Shri A.K. Gehlot, JS(MR) informed during the hearing that he has written a letter in this regard to DoPT and it is under process. Further the similar RTI application was decided in case F.No.CIC/AA/A/2016/55, CICOM/A/2016/00054, CICOM/R/2016/00040 dated 06.07.2016 in which it is felt necessary that the matter should be placed before the Commission to take appropriate action as deemed fit by the Commission and accordingly Nodal Officer, Shri Y.K. Singhal CIC was directed to put-up the matter before the Commission to take further course of action.

- 4. However, Shri A.K. Gehlot, JS(MR) informed during the hearing that a new link has been inducted in the CIC's website in which citizen can now see the RTI applications sent to the Commission and its replies. The appellant has stated during the hearing that he has seen that link but he noticed that the RTI applications have not been uploaded serially and there is a gap. In support of his statement, the appellant has also submitted a list of RTI applications uploaded in that link and it is found that the observation of the appellant is correct. Direction is accordingly given to Shri A.K. Gehlot, JS(MR) to get the problem rectified so that RTI applications are uploaded serially as per their registration number.
- 5. The appeal is, therefore, disposed off.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
