## Decision with reasons:-

- 2. During the hearing, the appellant has informed that he has received the reply on Point (A) of the RTI application from Shri M.K. Sharma, Registrar.
- 3. On Points (B) to (D) of the RTI application the appellant has sought the inspection. On these points, the appellant has sought following information:-
  - "(B) Please provide the copies of the Audit Reports from the year 2011-12 till the date of providing the information.
  - (C) Please provide the List of the Expenditure Heads from the year 2014-15 till the date of providing the information.
  - (D) Please provide the amount spent during the Financial year 2014-15 and 2015-16 under the following heads:
    - i) Transport including hiring of taxis and staff cars.
    - ii) Other Establishment Expenses.
    - iii) Stationery and Printing Expenses.
    - iv) Computer and Computer consumables including AMCs, Toners and repairs and Software development."

Direction is accordingly given to Shri S.K. Rabbani, DS(GA) cum CPIO to provide the inspection of above mentioned records to the appellant with mutual convenient date.

- 3. On Points (E) to (I) of the RTI application, the CPIO, Legal Cell has responded that "Information asked is voluminous. Collate and collection of such information would disproportionately divert the resource of this office." On points (E) to (I), the appellant has sought following information:-
  - "(E) Please provide a list of the records, Registers, Diaries maintained in the Legal Cell and also in the office of the Jt. Secretary (Law).
  - (F) Please provide copies of the Dak Inward and Dak Outward Register of the office of the JS(Law) and the Legal Cell of the CIC for the years 1.1.2015 till the date of providing the information.
  - (G) Please provide datewise details of the action taken in relation to the Dak received in the office of the JS(Law) and the Legal Cell of the CIC.
  - (H) Please provide the copies of all communications, orders, directions, remand directions, decrees and notices received from the High Courts and the Hon'ble Supreme Court of India, in whatever form they are available. This information may be provided for the period 01.01.2015 till the date of providing the information.
  - (I) Please provide date-wise copy of the register maintained in relation to the orders, judgments, directions or communications received from High Courts and Supreme Court. If manual records are not maintained then digital records may be provided or the records in whatever form they are available.
- 4. During the hearing the CPIO, Legal Cell has stated that the information being voluminous cannot be provided to the appellant. However, direction is given to the CPIO, Legal Cell to provide the information on Points (E) and (F) to the appellant within 5 working days from the date of receipt of the order and offer the inspection on the information sought in Points (G), (H) and (I) to the appellant with mutual convenient date.
- 5. The appeal is disposed of accordingly.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
