  - (B) Please provide the action taken on each of the Dak received in the Legal Cell from the Dak Section from 01.04.2013 till 30.06.2013 as per the enclosed list. This information may be provided in relation to the Dak for which no files have been opened.
  - (C) After providing the above information, please provide inspection of all records, documents, note-sheets and files relating to the information as referred to in point (A) to (B) above. Please provide inspection of complete file(s) even if they contain part of the information. Please note that I will undertake the inspection only if it is necessary in view of incorrect and incomplete information provided by you."

The CPIO, Legal Cell vide letter dated 25.02.2016 has replied that

"Information asked is voluminous. Collate and collection of such information would disproportionately divert the resource of this office."

- 3. The response of the CPIO is factual as a list of total 113 diary numbers have been provided by the appellant on which he has sought information on Points (A) & (B) of the RTI application. However, the CPIO, Legal Cell is directed to provide the inspection to the appellant with mutual convenient date.
- 4. The appeal is, therefore, disposed of accordingly.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
