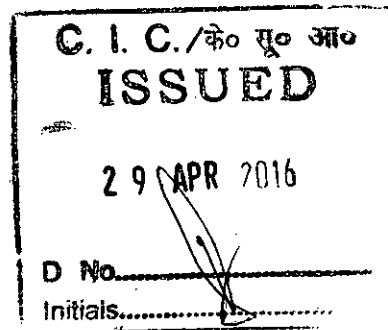
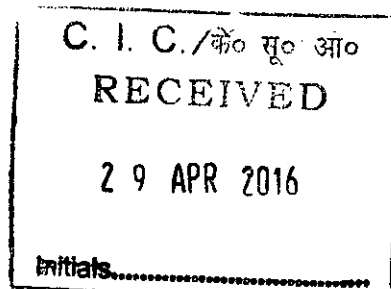

The appellant was given an opportunity to present his case, either personally or through an authorized representative or through audio conferencing. The appellant was present when Shri Y.K. Singhal, JS cum CPIO, RTI Cell and Shri V.D. Naniwadekar, DO to IC(YA) were also present. Shri Sushil Kumar, DS(Admin) cum CPIO was on leave.

**Decision with reasons:-**

1. The appellant has stated during the hearing that as per the response dated 05.02.2016 of Shri Sushil Kumar, DS(Admin) cum CPIO on Points 5 & 6 of the RTI application, he searched the CIC's website but no such information is found. **Direction is accordingly given to Shri Sushil Kumar, DS(Admin) cum CPIO to provide the information as sought in Points 5 & 6 regarding all the Legal Assistants attached with each of the ICs within 2 weeks from the date of receipt of the order.**

2. The appellant has also stated during the hearing that he has not received any response on Points 1 to 4 of the RTI application. It has been intimated by the SO, RTI Cell during the hearing that the points 1 to 4 are concerned with the DO to IC(YA) but it could not be transferred inadvertently. **Direction is accordingly given to Shri V.D. Naniwadekar, CPIO cum DO to IC(YA) to provide the information to the appellant within a week from the date of receipt of the order, as per the provision of RTI Act. A copy of the RTI application is enclosed.**
