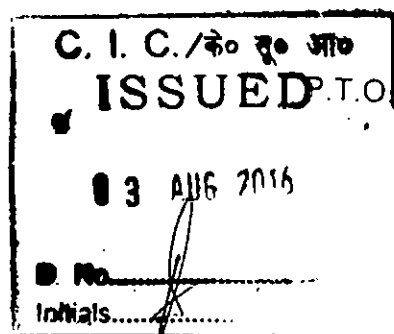
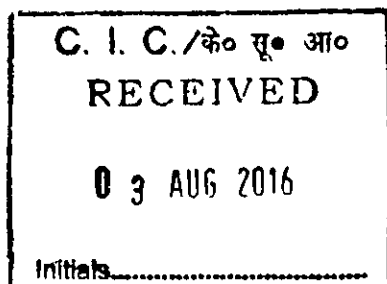

The appellant was present when Shri Krishan Avtar Talwar, CPIO cum DO to IC(KY) and Shri Rakesh Malik were also present during the hearing.

**Decision with reasons:-**

2. During the hearing, the appellant has informed that he has received the information sought in the RTI application from Shri Krishan Avtar Talwar, DO to IC(KY) and Shri Rakesh Malik, Scientist-E, NIC, CIC. The appellant has stated during the hearing that the information provided by NIC through RTI Cell is not satisfactory as he specifically sought the copies of records including digital records of NIC regarding the requests received from CIC/ICs for arranging/coordinating video-conferencing during the year 2015 held by Shri M.A. Khan Yusufi, Information Commissioner. But the NIC has given a list of 76 slots booked by NIC during the year 2013 to 2015 without mentioning the name of the registry concerned though he has sought the information pertaining to Shri M.A. Khan Yusufi, Information Commissioner only. Direction is accordingly given to Shri A.K. Gehlot, JS(MR) cum CPIO to get the information from NIC at CIC for the year 2014-2016 and provide it to the appellant within 2 weeks from the date of receipt of the order.

3. The appeal is, therefore, disposed off accordingly.
