Decision with reasons:-

- 1. In the RTI application, the applicant sought attested copies of action taken on representation dated 07.07.2014 and its subsequent reminder dated 28.08.2014 and 02.01.2015. The CPIO, Dak Section, Mrs Pushpa Janardhanan vide her letter dated 08.02.2016 has responded that "The Dak Management system of this Commission do not indicate receipt of communication dated 07.07.2014, 28.08.2014 and 02.01.2015 from you."
- 2. The appellant in the first appeal has enclosed a copy of the aforementioned representations and after perusal of the copy of the representations, it has been observed that the representations have been made by Shri B.C. Parchha and not by the appellant Shri Parveen Kumar, therefore, CPIO, Dak Section could not find the same in the computerized dak management system of the Commission. The appellant should have mentioned the name of the sender in the RTI application.
- 3. However, after searching by name of Shri B.C. Parchha in the computerized dak management system, it is seen that the representation dated 07.07.2014 and its reminder dated 28.08.2014 had been diarized as Diary No.150903 dated 11.07.2014

and Diary No.165106 dated 05.09.2014 respectively and both are marked to DO to
