Decision with reasons:-

1. In the RTI application, the applicant has sought following information regarding engagement of Legal Consultants in CIC:-

- (1) List of selected candidates with their marks obtained.
- (2) Marks obtained by me.
- (3) Cut off marks of each categories.
- (4) Total number of candidates appeared for the interview and my rank in the list.
- (5) Criteria adopted for selection process."

The CPIO cum DS(Admn), Shri Sushil Kumar responded that:-

"The criteria adopted for selection of candidates is as per CIC notice dt. 18.11.2015. 400 candidates were shortlisted for interview which was conducted by the selection committee and the candidates were selected based on their performance in the interview."

The appellant in the first appeal has mentioned that the CPIO has provided unsatisfactory, vague and evasive reply. The appellant further mentioned in the first appeal that the CPIO has not provided the information for my following questions:-

- (1) Marks obtained by me in the interview for Legal Consultant?
- (2) My position in the order of merit prepared by the Commission?"

Direction is accordingly given to Shri Sushil Kumar, DS(Admn) cum CPIO to provide the information on above mentioned two points to the appellant within two weeks from the date of receipt of the order.
