The appellant was present when Shri Y.K. Singhal, JS cum CPIO, RTI Cell and Shri Sushil Kumar, DS(Admin) cum CPIO were also present during the hearing.

Decision with reasons:-

1. In response to Point (A) to (D) of the RTI application, it was intimated by the DS(Admin) cum CPIO vide letter dated 18.03.2016 that "The letter no.11026/2/2014-ISS dt. 24.02.2014 directly received from MOSPI is not available on record. However, the said letter dt. 24.02.2014 is received as an enclosure with another letter dated 14.1.2014 received from MOSPI."


In the first appeal the appellant has alleged that the CPIO has not made any attempt for searching the said letter and never informed the appellant about the misplacement of the letter.

However, in the computerized dak management system, it is seen that the above said letter of MOSPI was diarized as Diary No.116756 dated 26.02.2014 and marked to Secretary, CIC. On further inquiry from all concerned, it is found that the letter was received in the Secretary's office and finally sent to DS(Admin) through Additional Secretary and JS(Admin) (JS(Admin) diary register No.716 on 06.03.2014). Since the letter in question was sent to the DS(Admin), direction is accordingly given to Shri Sushil Kumar, DS(Admin) cum CPIO to re-visit the matter and provide the information as sought in above points to the appellant within 2 weeks from the date of receipt of the order.
