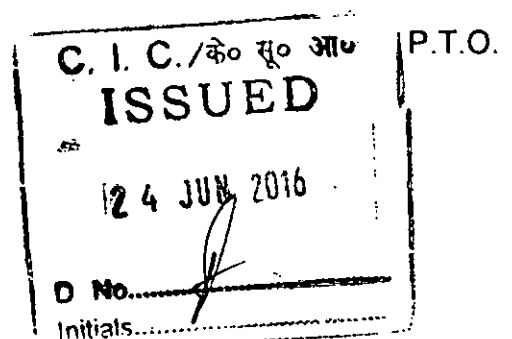
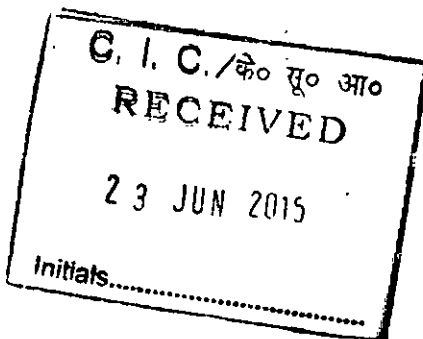

The appellant was given an opportunity to present his case personally or through representative or through audio/video conference on 03.06.2016 but he did not avail. The appellant was also contacted over mobile number given in the appeal but found not reachable.

Decision with reasons:-

1. In the first appeal, the appellant has alleged that the information provided by Shri Dinesh Kumar, DR in Central Registry is incomplete, absurd and does not convey the correct information. From the perusal of the computerized dak management system of the Commission, the letter dated 10.11.2015 has been diarized as Dy.No.178335 dated 03.12.2015 and registered as case File No.CIC/RK/A/2016/000826. Therefore, the reply dated 25.02.2016 of the CPIO, Shri Dinesh Kumar is correct and appropriate. However, the appellant in his RTI application also wants to know the likely date of hearing of his appeal No.CIC/RK/A/2016/000826. Direction is accordingly given to Shri K.L. Das, CPIO cum DO to IC(BJ) to provide the present status of the above mentioned appeal to the appellant within 5 working days from the date of receipt of the order.

2. The appeal is, therefore, disposed of accordingly.
