

Decision with reasons:-

- 1. In the RTI application, the appellant has sought the diary numbers and the status of his 16 letters/second appeals/complaints filed in this Commission. CPIO, RTI Cell has forwarded the RTI application to a number of CPIOs. Instead of sending it to number of CPIOs, the CPIO, RTI Cell should have transferred the RTI application to the Dak Section only who is concerned with the diarisation of the letters/appeals/complaints received in the Commission. Also in the reply dated 15.03.16 of Shri Dinesh Kumar, DR in Central Registry though has provided the diary numbers but not mentioned that against which letter/appeal/complaint of the appellant, the diary numbers has been generated and the files have been registered.
- 2. The CPIO, Dak Section is directed to get diary numbers against each of the letters/appeals/complaints as mentioned by the applicant in the RTI application and also the file number if it is available against the diary number to the appellant within 3 weeks so that the appellant can get to know the correct diary number/file number against the appeal he has filed in this Commission.
