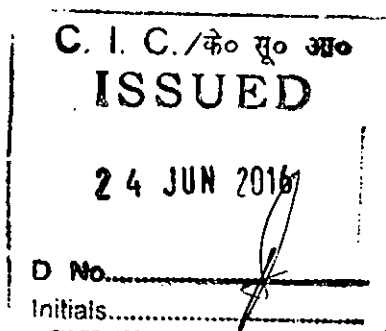
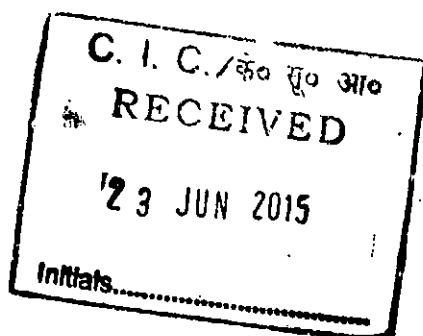

The appellant is aggrieved that the response furnished by the three CPIOs of the Commission without requisite any information with excuse of files not available and no response from the DO & CPIO, Shri V.D. Naniwadekar till date in response to the queries of his RTI application regarding pending complaints against non-compliance of Hon'ble CIC's Decisions. However, from the perusal of the first appeal, it is observed that the appellant himself enclosed a copy of the reply dated 18.04.16 received from Shri V.D. Naniwadekar, therefore, the response has not been received does not arise.

Decision with reasons:-

1. In the first appeal, the appellant has stated that he has not received information on the status of his complaints etc asked for in his RTI application and the CPIO concerned had replied that the concerned case files are not available. Direction is accordingly given to Shri R.P. Grover, CPIO & DO to IC(YA), Shri V.K. Sharma, CPIO & DO to IC(VS) and Shri Babu Lal, CPIO & DO to IC(SA) to take the help of the I/c Record Room and JS(MR) who is compiling the files of this Commission and get the files and provide the information to the appellant within 3 weeks from the date of receipt of the order.

2. Direction is also given to Shri A.K. Gehlot, JS(MR) and Shri Mukesh Kumar, I/c Record Room to trace the case files and if available hand it over to the concerned CPIOs for providing further information within 1 week from the date of receipt of the order.

3. The appeal is disposed off accordingly.

4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
