The appellant vide his letter No.RTI/P-737/9679/16/R20142 dated 13.09.2016 has intimated that he would be busy in Pooja and other religious ceremonies on the occasion of Anant Chaturdashi (Jain's Annual Day), his presence for the hearing may be dispensed with and the appeals may be decided on the material available on records. He also stated that in case, CPIO has filed any written submissions/replies, provide a copy thereof so that he may file a response and in that circumstances, appeals may be decided after consideration of his response. In this regard, it is stated that no written submission has been received from any of the CPIO(s). Shri M.K. Sharma, Registrar, Shri T.K. Mohapatra, DO to IC(MP), Shri Ashok Kr Sharma, CPIO, RTI Cell, Shri V.K. Sharma, DO to IC(SB), Shri Krishan Avatar Talwar, DO to IC(KY), and Shri R.P. Grover, DO to IC(YA) were present during the hearing.

Decision with reasons:-

In the RTI application, the appellant has sought date-wise details of action taken on his 17 letters sent to the Commission and also sought file number in which these 17 letters were dealt and also copies of all note sheets and correspondence pages of the said files. CPIO, RTI Cell vide letter dated 11.01.2016 has forwarded the RTI application to the Registrar, DO to IC(MP), DO to IC(YA), DO to IC(SA) and DO to IC(BS). The appellant in his appeal has mentioned that CPIO, RTI Cell and other CPIOs have not provided complete and correct information. The CPIO may be directed to provide consolidate information.


Direction in this regard is given to the CPIO, RTI Cell to check the responses provided by various CPIOs and seek assistance under Section 5(4) from the concerned CPIO/holder of the information in respect of the letters on which information has not been received or provided to the appellant and provide a consolidated information/reply to the appellant within 3 weeks from the date of receipt of the order.
