

Decision with reasons:-

- 1. In the RTI application, the appellant has sought following information:-
 - "(a) Can CIC, New Delhi take the parliamentary proceeding against the corruption by democratic Governance and violation of human right, for compensation amount with compound interest to applicant to their RTI application as well as its official proceeding to appropriate time frame within one hundred and twenty days, by Court of CIC, New Delhi.
 - (b) Can CIC, New Delhi take the copy of Judgment/decision against my application dated 01 April 2016 from UNHRC, Genewa, Switzerlant?
 - (c) Can the Parliamentary action taken from CIC, New Delhi based the circumstances of application dated 01 April 2016 and available record to my CASE in CIC, New Delhi, for violation of my human right and penalty amount of compensation to applicant with compound interest from Court of CIC or State Information Commission by video conferencing system to any network nexus to the unconstitutional, illegal and moral-less application by officers and employees to Govt. of Bihar involve directly as well as officers and employees to Govt. of India involve indirectly to vide letter No.18/09/P-2/08 dated 22.09.2008, issue by President's Secretariat, Rashtrapati Bhawan, New Delhi, PIN 110004?
- 2. The CPIO, RTI Cell vide reply dated 02.05.2016 has responded that:-

"In this regard, it is stated that you may refer to RTI Act, 2005 & RTI Rules, 2012 which are already available in public domain."

- 4. The appellant has mentioned himself as the "Agent to the Government". It is not understood for which purpose he has been appointed as agent and which government has appointed him as its agent.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
