Decision with reasons:-

1. In the RTI application, the appellant has sought following information:-

*"(1) Attested copy of action taken on my representation dated 16th Sept, 2015
(copy enclosed) required.*

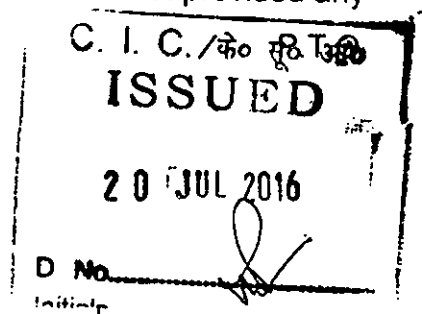
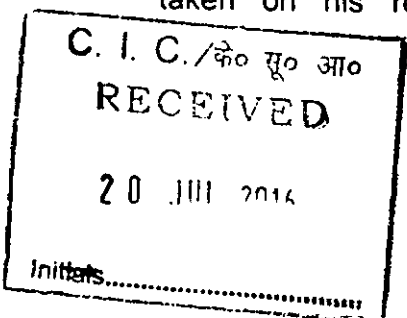
*(2) Why Commission have not directed the respondent to provide the information
to the appellant on point No.1 & 2 in his decision on 12th August, 2015 after
hearing the 2nd Appeal on 5th August, 2015 (copy enclosed).*

*(3) So the aforesaid points are still pending with Commission due to appellant got
Part Decision only his appeal.*

2. On Point-(1), the CPIO cum DO to IC(YA) vide letter dated 31.03.2016 has informed that:-

*"In so far as Point Number 01 of the representation dated 16.09.2015 is
concerned, it is informed that as per the information available in the CIC, the
Respondents have provided the desired information to the Appellant."*

3. However, in the RTI application, the appellant has sought attested copy of action taken on his representation dated 16.09.2015. The CPIO has not provided any


information on the action taken on that letter. Direction is accordingly given to DO to IC(YA) to provide the information on the action taken on the representation dated 16.09.2015 to the appellant within one week from the date of receipt of the order.

4. On Point 2 & 3 of the RTI application, the appellant has raised questions on the decisions of the Commission. The CPIO and the FAA of the Commission has no jurisdiction to comment on the decisions of the Commission.

5. The appeal is, therefore, disposed off accordingly.

4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.


