**Decision with reasons:-**

1. In the RTI application, the appellant has sought information on 7 points in connection with case File No.CIC/YA/A/2015/000144. The CPIO cum DO to IC(YA) vide his letter dated 22.04.2016 has informed that:-

*"In this connection it is informed that earlier this Registry was located in Room Number 327 and subsequently, we have shifted to Room Number 309. During shifting of files and furniture, the file number CIC/YA/A/2015/000144 seems to have been mixed up with other files. It is requested that 15 (fifteen) days more time may be given to locate the said file and to provide the desired information."*

2. In this first appeal, the appellant has stated that the 15 days period has too expired but he has not received any information. **Direction is accordingly given to CPIO cum DO to IC(YA) to provide the information to the appellant within 2 weeks from the date of receipt of the order.**

3. The appeal is disposed off.

4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 185, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
