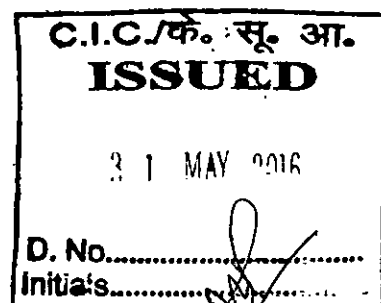
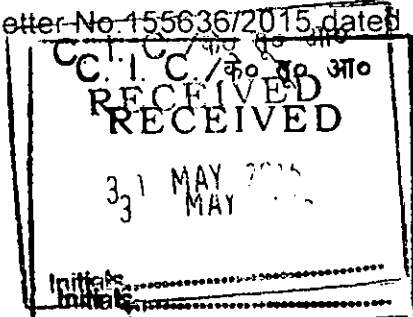

**Decision with reasons:-**

1. In the RTI application dated 28.03.2016 addressed to Smt. Manjula Prasher, the applicant has sought certain information, which is not understood. The said RTI application has been diarized as Dy.No.127908/2016. However, in the first appeal the appellant has mentioned Diary No.155636/2015, therefore, it seems that in the RTI application, the applicant wants to know the action taken on the said diary number. Shri Dinesh Kumar, DR in Central Registry has informed that the Diary No.155636/2015 was returned to the appellant due to deficiency in documents vide his letter dated 19.11.2015. Further, the CPIO informed that Diary No.127908/2016 has also been returned to the applicant due to deficiency in the documents as he thought that it was an appeal because it was addressed to Mrs. Manjula Prasher, IC(MP). Shri Dinesh Kumar, CPIO cum DR in Central Registry is advised to read the application thoroughly before returning it to the applicant.

2. The appellant is advised to resubmit his appeal/complaint to the Commission enclosing all relevant documents as intimated by the CPIO cum CR in Central Registry vide letter No.155636/2015 dated 19.11.2015 (copy enclosed).
