The appellant vide his letter No.RTI/P-737/9679/16/R20142 dated 13.09.2016 has intimated that he would be busy in Pooja and other religious ceremonies on the occasion of Anant Chaturdashi (Jain's Annual Day), his presence for the hearing may be dispensed with and the appeals may be decided on the material available on records. He also stated that in case, CPIO has filed any written submissions/replies, provide a copy thereof so that he may file a response and in that circumstances, appeals may be decided after consideration of his response. In this regard, it is stated that no written submission has been received from any of the CPIO(s). Shri M.K. Sharma, Registrar, Shri Ashok Kr Sharma, CPIO, RTI Cell, Shri V.K. Sharma, DO to IC(SB), Shri Krishan Avatar Talwar, DO to IC(KY), Shri Dinesh Kumar, DO to IC(SA), Shri Raghubir Singh, DO to IC(DP), Shri A.K. Talpatra, DO to IC(AB) and Shri R.P. Grover, DO to IC(YA) were present during the hearing.

Decision with reasons:-

2. On Point (A) (i), factual information has been furnished by Shri M.K. Sharma, Registrar, hence no intervention is required.

3. On Point (A) (ii), the appellant has sought following information:-
"Please provide copies of the cause list/list of cases prepared for ICs and those heard and disposed of by the ICs from 01.04.2016 till the date of providing the information."

The above information are available in the CIC's website, therefore, no need to give any direction to the individual registries to provide the cause list, which has already been uploaded in the website.

4. On Point (A) (iii), all DRs/DOs present during the hearing have informed that the attendance sheets are placed in the concerned case files and no separate folders are maintained for attendance sheet. Moreover, this information is scattered in various individual files, hence the information is voluminous and it would disproportionately divert the resources. Hence, no direction can be given to the CPIOs for providing the information/documents as sought by the appellant.

5. On Point (A) (iv), the appellant has sought following information:-

"Please provide details of the steps taken for showing all cases in the public cause list, which are listed of hearing before each IC."

Shri A.K. Gehlot, JS(MR) & CPIO has replied as under:-

"A(iv). Cause list is available online on website of Central Information Commission (www.cic.gov.in/). All designated Officers (DO) of the registries are responsible for updating this list."

The CPIO in his reply has not mentioned the details of the steps taken for showing all cases in the public list, which are listed for hearing before each IC as sought in the RTI application. **Direction is accordingly given to Shri A.K. Gehlot, JS(MR) & CPIO to provide a copy of the relevant instructions/circular, if any, in respect of steps taken to the appellant within 1 week from the date of receipt of the order.**

6. On Point (A) (v), the appellant has sought following information:-

"Please provide after court cause list of all the ICs and CIC from 1-1-2016 till the date of providing the information."

Shri M.K. Sharma, Registrar has informed during the hearing that there is no such after court cause list maintained in the Commission.


7. On Point (A) (vi) of the RTI application, Shri V.K. Sharma, DO to IC(SB) vide letter dated 02.05.2016 has provided the factual information, hence no further information can be provided.

8. On Points (B) & (C) of the RTI application, the Registrar and JS(MR) doing the re-conciliation of all the files in the Commission. Hence the Registrar, **Shri M.K. Sharma is directed to provide an appropriate reply to the appellant, if required assistance from JS(MR) may be taken.**

9. The appeal is disposed off accordingly.

10. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
