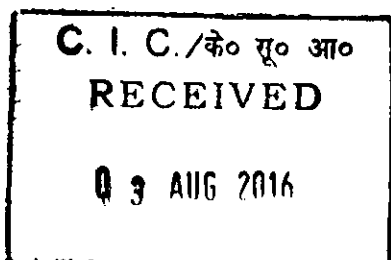
The appellant was present when Shri Sushil Kumar, DS(Admin) was also present during the hearing.

**Decision with reasons:-**

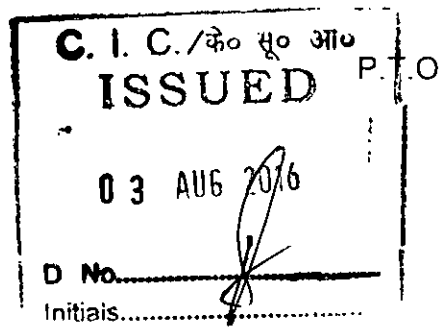
2. During the hearing, the appellant has stated that he is only aggrieved with the reply on Points (B) & (C) of the RTI application received from the CPIO cum DS(Admin), Shri Sushil Kumar. The appellant has stated that on Point (B) he has sought complete details of all fields and data recorded in the Biometric Attendance System from 01.01.2015 but the CPIO has given incomplete information. **Direction is accordingly given to Shri Sushil Kumar, DS(Admin) cum CPIO to re-visit RTI application and provide complete information to the appellant within 10 working days from the date of receipt of the order.**

3. On Point (C) of the RTI application, the CPIO, Shri Sushil Kumar has informed the appellant vide letter dated 18.05.2016 that, *"The biometric systems installed at CIC sometimes may not be functional due to technical reasons which is rectified by NIC team at CIC. No such record is maintained."* Since factual information has been furnished by the CPIO, no further information can be provided.

4. The appeal is, therefore, disposed of accordingly.
