The appellant is aggrieved that the CPIO concerned has not provided any reply/information of his RTI application dated 18.02.2016 though approx. 2 months period has been elapsed.

**Decision with reasons:-**

1. In the RTI application, the applicant had sought information in respect of letter dated 23.11.2015 bearing Dy. No.173807/2015, letter dated 07.12.2015 bearing Dy.No.173805/2015 and letter dated 11.12.2015 bearing Dy.No.178815/2015. On inquiry from the RTI Cell, it has been informed that the said RTI application was diarized as Diary No.116610 dated 26.02.2016 returned to the Central Registry by the then S.O., RTI Cell on 03.03.2016 through peon book but the reasons of return is not known. When the matter was enquired from the Central Registry, it was informed that the said RTI application was received back from the RTI Cell but presently it is not readily traceable. Shri Dinesh Kumar, CPIO cum DR in Central Registry is advised to maintain records properly so that such mistake not occur, in future. However, the CPIO, RTI Cell instead of returning the RTI application to the Central Registry, should have furnished suitable reply to the applicant. The CPIO, RTI Cell is advised not to repeat such mistake in future and read the RTI application thoroughly before sending it to any other section.
