The appellant has intimated over phone that he is not well, therefore, his first appeal may be decided on merits on the basis of available record and material. Later on, he also intimated the same in writing vide letter dated RTI/P-737/9869/16/R/19791 dated 24.08.2016.

Decision with reasons:-

1. During the hearing, Shri Ashok Kumar Sharma, CPIO, RTI Cell has informed that the appellant has submitted a letter dated 23.06.2016 intimating therein that the information sought by him concerning to the registry of IC(SB) is not required at this late stage and requested to refund the amount of Rs.218/- deposited by the appellant. Accordingly, Shri V.K. Chandok, ex. CPIO, RTI Cell has returned a DD of Rs.218/- to the appellant vide letter No.CICOM/R/2016/00581 dated 06.07.2016.

2. On Point (D) of the RTI application, the appellant has sought following information:-

"Please provide the procedure for registration and hearing of the matter when the second appeal is filed by the CPIO or by the Public Authority and the person/organization which is treated as Respondent in such case."

Shri Y.K. Singhal, JS(Law) & ex. CPIO, RTI Cell has responded as under:-

"You may refer to RTI Act, 2005 & RTI Rules, 2012 are already available in public domain".


The appellant has stated in the appeal that *"....no information is contained in the said Act or the Rules, which answers/refers to the information sought by the appellant....."* The Registrar is in a better position to reply on this point. **Accordingly, Shri M.K. Sharma, Registrar is directed to provide the information on point (D) to the appellant within 1 week from the date of receipt of the order.**

3. On the reply of the CPIO on point (E) of the RTI application, the CPIOs stated that there is no such record maintained separately in respect of cases filed by CPIOs or the public authority in this Commission and also it is not available separately in the computerized data management system of the Commission. Hence, no direction can be given.

4. The appeal is disposed off accordingly.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
