The appellant has intimated over phone that he is not well, therefore, his first appeal may be decided on merits on the basis of available record and material. Later on, he also intimated the same in writing vide letter dated RTI/P-737/9869/16/R/19791 dated 24.08.2016. Shri Ashok Kr Sharma, CPIO, RTI Cell and Shri V.K. Sharma, CPIO cum DO to IC(SB) were present during the hearing.

Decision with reasons:-

2. In the RTI application, the appellant has sought inspection of case File No.CIC/LS/A/2013/001328 and No.CIC/DS/C/2013/000521. Shri V.K. Sharma, CPIO cum DO to IC(SB) vide letter dated 01.06.2016 has furnished following information:-

"Please refer this registry's letter of even no. dated 18.05.2016. In-charge, Record Room, CIC to whom a reference was made has informed vide their letter dated 17.05.2016 (copy enclosed) that file nos.CIC/LS/A/2013/001328 and CIC/DS/C/2013/ 000521 have not been received in the record room."

3. Since the case files are very old, it may not be available in physical form and may be available in electronic form. **Accordingly, Shri V.K. Sharma, CPIO cum DO to IC(SB) is directed to take the assistance of JS(MR) for getting electronic data of the concerned case files, if available and provide the inspection to the appellant with mutual convenient date.**

4. The appeal is disposed off accordingly.
