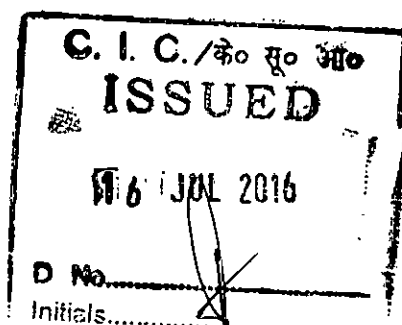
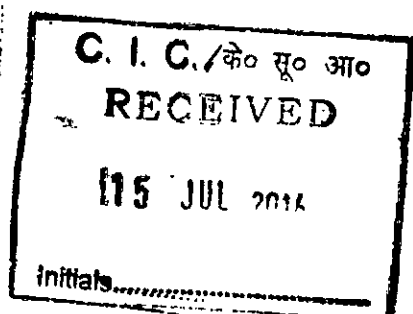

**Decision with reasons:-**

1. In the RTI application, the appellant has sought information through 21 points. The CPIO, RTI Cell has forwarded Points 1 & 2 to CPIO and DO to CIC(RK). On rest of the points the CPIO RTI Cell has advised to refer this matter to the concerned Public Authority.

2. Shri S.C. Sharma, DO to CIC vide his reply dated 25.05.2016 has intimated that the appellant's concerned case File No.CIC/WB/A/2007/775 is not available in the Registry and the information will be supplied as soon as the record is received in the Registry. The appellant has filed this first appeal against the reply of Shri S.C. Sharma.

3. Since the file is very old one, it may not be available in physical form and may be available in scanned document. **Therefore, the CPIO, Shri S.C. Sharma is directed to take the assistance of JS(MR) to get the scanned document, if available for providing information to the appellant.** The CPIO has already intimated regarding the availability of the order of the Commission in the website. The appellant can down load the said order from the Commission's website – [www.cic.gov.in](http://www.cic.gov.in). On the other points, the appellant has not raised anything in the first appeal.
