Decision with reasons:-



1. In response the RTI application, the information provided by the concerned CPIOs of the Commission on Points - 1.0 (a) & (b) and 2.0 (1) to (10) is factual and on the basis of available records with the CPIOs. Hence, no intervention is required on the reply of the CPIOs.

2. On Points 1(c) of the RTI application, the appellant has stated that he has not received the information. On point 1(c), the appellant has sought following information:-

".....[c] Competency of bench of Hon'ble Shri M. Sridhar Acharyulu, IC to hear these case in violation of Statutory provisions U/S 18/19/12(4)/2(b) of RTI Act-2005 [As clarified by DOP&Trg Vide O.M. No.1/1/2009-IR Dated 22.05.2009, wherein it is clear that this function is to be discharged by the COMMISSION and not by constitution the BENCHES].

In this regard, it is to inform that CPIO and the FAA of the Commission cannot comment on the decision of the Commission or interpret the rules as sought by the appellant.

3. Point 1.0(d) has been transferred by DO to IC(BS) to DO to IC(SA) and as per the appeal, the appellant has not received the information, direction is accordingly given to Shri Dinesh Kumar, CPIO cum DO to IC(SA) to provide the information to the appellant within 10 days from the date of receipt of the order.



4. The appellant is further informed that he may know the status of his various letters sent to this Commission on different dates from CIC's Helpline No.011-26183053 or concerned registry whose contact numbers are available on the CIC's website to get the information. The status of the letters sent to the Commission is also available in the CIC's website "www.cic.gov.in – Status of Appeals and Complaints – Diary Number – Name or diary number".

5. The appeal is, therefore, disposed off accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
