



## Decision with reasons:-

- During the hearing, the appellant stated that in the RTI application he has sought 1. true certified copy of the second appeal decision in case File No.CIC/RM/A/2012/000926. But, the CPIO, Shri R.L. Gupta has denied to provide the certified copy of the decision by quoting a decision of the Commission vide his letter dated 25.05.2016. Hence, not satisfied by the denial of the information, he has filed the first appeal and requested for providing him a certified copy against the requisite fee, if any.
- 2. After hearing the appellant and the CPIO, the FAA is of the view that since there is no devised procedure in the Commission for getting a certified copy of the order of the Commission in a particular case, the RTI is the only way to get a copy of the order.
- 3. In view of the above, direction is given to Shri R.L. Gupta, CPIO cum DO to IC(BS) to provide a certified copy of the above mentioned decision to the appellant free of cost within 5 working days from the date of receipt of the order.
