
Decision with reasons:-

1. In the appeal, the appellant has stated that he has not received the reply of his RTI application dated 14.06.2016. It has been observed that the CPIO, RTI Cell vide letter No. CICOM/R/2016/00844 dated 30.06.2016 has forwarded the said RTI application to Shri S.C. Sharma, DO to CIC(RK) and Shri Dinesh Kumar, DO to IC(SA).
2. It is also observed in the RTI-MIS software that Shri Dinesh Kumar, DO to IC(SA) has wrongly uploaded a reply of RTI application No.CICOM/R/2016/00780 in place of the reply of RTI No.CICOM/R/2016/00844 against which this appeal has been filed by the appellant. **Direction is accordingly given to Shri Dinesh Kumar, DO to IC(SA) to provide the information to the appellant and if already furnished, copy of the same be sent to the appellant within 1 week from the date of receipt of the order.**
3. **Shri S.C. Sharma, DO to CIC(RK) is also directed to provide the information to the appellant and if already furnished, copy of the same be sent to the appellant within 1 week from the date of receipt of the order.**
4. The appeal is disposed off accordingly.
