## Decision with reasons:-

1. 2. Direction is accordingly given to Shri V.K. Sharma, CPIO cum DO to IC(SB) to put his best efforts once again for tracing the above mentioned file and if it is not traced out then the CPIO is directed to take the assistance of JS(MR) to get the scanned document as the file is very old one, it may not be available in physical form, and may be available in scanned document and provide the information to the appellant within two weeks from the date of receipt of the order.



- 3. The appeal is disposed off accordingly.
- 4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No. 185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
