**Decision with reasons:-**

1. The appellant has sought information on the complaint filed in the Commission in respect of non-furnishing of information by the CPIO, FCI, Bangalore as per order No.CIC/YA/A/2014/002816. The CPIO, Shri Krishan Avtar Talwar has provided him the available information and advised him to file separate petition under Section 18 of the RTI Act in the Central Registry of the Commission for the purpose.

2. In the appeal, the appellant has stated that he has already filed a complaint under Section 18 on 21.01.2016 and prayed that his petition may be placed before the bench of the Commission for conducting proper enquiry. FAA of the Commission has no authority to interfere or direct the CPIO for taking up or disposal of any of the petitions filed in the Commission. Hence, no direction can be given to the CPIO, in this regard. **However, the CPIO, Shri Krishan Avtar Talwar is advised to look into the petition filed by the appellant as stated in his RTI application and take necessary action, as deemed fit.**
